



# HISTORIC SEAPORT MARINA 2010 Race Week Reservation Policy

The Historic Seaport Marina has developed a timeline and guidelines that will promote better communication regarding race week dockage applications and their status. The City owned Historic Seaport Marina (HSPM) is a highly desirable location and this new policy is designed to maximize the availability of slips for race week participants. The further objectives of this formal policy are to allow for timely processing of applications, communicate the status of wait-listed boats, and set a clear policy for deposits and refunds. Returning boats have the opportunity to secure their reservations early.

The following timeline is a guideline which was implemented for the 2009 race week and should continue to help improve the reservation process. We ask for your continued cooperation with the HSPM dock staff as they work to refine these policies and procedures. Returning boats should note the August 15 application deadline in order to lock in their space early for the coming year.

## August 1

Premiere Racing will:

- Post the HSPM application on their event web site ([www.Premiere-Racing.com](http://www.Premiere-Racing.com)).
- Contact all race boat owners by email who moored their boats at HSPM and notify them of the HSPM reservation policy and their need to submit their dockage application no later than Aug 31. A 50% deposit will be secured at time of confirmation (non-refundable after Sept 15). On Nov 15, the remaining 50% will be charged (fully non-refundable at that time).

## August 31

**Deadline for the previous regatta's race boats to commit to dock space for the following year** (refundable deposit until September 30). Dockmaster will begin assigning returning race boats to slips and processing other applications submitted by that date.

## August 31-Sept 15

HSPM will send an email notification to all race boat owners who have submitted applications (by the August 31 deadline):

- Returning boat owners are notified of their marina location and that their first 50% deposit will become non-refundable on September 15, and the remaining 50% for the reservation will be non-refundable on November 15;
- Those new boats that are assigned slips at this time are confirmed, told of their marina location and that their first 50% deposit will become non-refundable on September 15, and the remaining 50% for the reservation will be non-refundable on November 15;
- Those applicants who can not yet be assigned slip or dock space are notified that they have been placed on a formal "waiting list" and notified that an update will be provided by September 15.

## September 15

**50% deposits for all boats are fully non refundable at this time.**

All applicants on the waiting list are notified with their assigned slip or where they stand on the waiting list, and that the next formal notification will be on November 1.

November 1

Boats will be reminded that remaining charges for their reservation will be fully non-refundable on November 15<sup>th</sup>.

All applicants still remaining on the waiting list are notified with their assigned slip or where they stand on the waiting list, and that the next formal notification will be on December 1.

November 15

**Remaining 50% of reservation for all boats is charged (fully non refundable going forward).**

December 1

All applicants still remaining on the waiting list are notified with their assigned slip or where they stand on the waiting list, and that the next formal notification will be on January 1.

January 1

All applicants still remaining on the waiting list are notified with their assigned slip or where they stand on the waiting list.
