I accept full responsibility for the conduct of each member of my crew and guests during our time on the WIP. I acknowledge that I have sole responsibility for the safety of my crew and yacht. Refusal to comply with the WIP rules and regulations may result in my being asked to leave the facility.

The City of Miami, Premiere Racing, and all Sponsors, Suppliers, Partners, and Agents of Miami Grand Prix, their officers, directors, members, committee personnel, volunteers, employees and agents are in no way to be held responsible for the loss of personal items or damage to personal property, accidents, damage to property or to yachts and/or personal injury to crew or guests arising from any cause during or related to any activity in the WIP. Each Skipper and his crew must evaluate weather and sea conditions and each participant is responsible for determining whether it is safe for his or her yacht to be docked or dry sailed at the basin. If S & S Mobile Marinas or Race Committee personnel provide assistance, it is at the risk of the participants.

In consideration of your application for services provided by S & S Mobile Marinas, that all services contracted by the Owner and provided by S & S Mobile Marinas shall be fully covered by S & S Mobile Marinas and their insurance company. All work performed by the Owner, Agent of the Owner, Captain or Third Party Contractor, shall be the responsibility of the Owner, Agent of the Owner, Captain or Third Party Contractor. These services performed by others shall not be the responsibility of S & S Mobile Marinas, their officers, directors, members, agents or any one or more of them or their executors, administrators, heirs, next of kin, successors, or assigns, including any or all claims for damage caused by the action of the Owner, agent of the Owner, Captain or Third Party Contractor and all costs and expenses including attorney's fees that may be incurred as a result of any claim whether valid or not.

S & S Mobile Marinas will not be responsible for the loss of personal items or damage to personal property, accidents, and personal injury to crew or guest arising from any cause during or related to any activity in the WIP.

In consideration of your accepting my application for services at the WIP, I do for myself, my executors, my administrators and assigns waive and release any and all claims that I have against the City of Miami, Premiere Racing, and all Sponsors, Suppliers, Partners, and Miami Grand Prix, their officers, directors, members, committee personnel, volunteers, employees and agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors, or assigns, including any or all claims for damage caused by the negligence of any of them arising out of my staying at the TAP including any activities on the premises together with any costs and expenses including attorney's fees that may be incurred as a result of any such claim whether valid or not.

I agree to the Mast Step/Unstep, Launch and Haul reservation policy and understand that the reservation schedule may be altered due to weather conditions, race delays, equipment troubles, or problems caused by other entrants. I also understand and agree that S & S Mobile Marinas or the City of Miami has the right to stop any of the operations at WIP for safety reasons for any period of time. Any financial hardship or additional expenses incurred as a result of the above conditions shall be the Owner's sole responsibility and Owner agrees to hold S & S Mobile Marinas and the City of Miami harmless. I agree to be prepared for my assigned reservations and understand that if I am not ready for any of my reservations that I will be reassigned to a later date and/or time.
