Premiere Racing, Inc., the Miami Beach Marina, the Cities of Miami and Miami Beach, and all Sponsors, Suppliers and Partners of AMGP, their officers, directors, members, committee personnel, volunteers, employees and agents are in no way to be held responsible for accidents, damage or injury to property or to yachts, crew or guests arising from any cause during or related to any activities of AMGP. Weather and sea conditions must be evaluated by each Skipper/Owner and their crew and each participant is responsible for determining whether it is safe for he or she to participate. The responsibility of wearing a life jacket rests upon the Skipper/Owner and their crew (except when required by class rules). If assistance is provided by committee vessels and personnel, it is at the risk of the participants.

I accept full responsibility for the conduct of each member of my crew and guests during AMGP. I acknowledge that I have sole responsibility for the safety of my crew and boat.

In consideration of your accepting my entry for AMGP, I do for myself, my executors, my administrators and assigns waive and release any and all claims that I have against Premiere Racing, Inc., the Miami Beach Marina, the Cities of Miami and Miami Beach, and all Sponsors, Suppliers and Partners of AMGP, their officers, directors, members, committee personnel, volunteers, employees and agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors, or assigns, including any or all claims for damage caused by the negligence of any of them arising out of my participation or that of my boat in AMGP and its related activities, including pre-start and post-finish operations and shore activities together with any costs and expenses including attorney's fees that may be incurred as a result of any such claim whether valid or not.
